Terms of Use

The objects of the Company are lease and sublease of vehicles. The Company is based in Attica Region, Amarousion, 14 Pigasou Street, TIN 801141110, tax authority for commercial authorities, registration number in General Electronic Commercial Registry 150045801000.
